Adapting to a New Congress

t this writing, the votes in two states and less than a dozen congressional districts are still being tabulated. We do know now that the Republicans will take control of the House, but with a very narrow majority. We also know that the Democrats, who currently hold 50 seats, will control the Senate by virtue of the vice president being able to cast tie-breaking votes. The election in Georgia will come down to a December run-off election when Senator Raphael G. Warnock (D-Ga.) will face Republican candidate Herschel J. Walker. This race will determine whether we will again have a 50-50 Senate or if the Democrats will control the Chamber with 51 seats.

Democracy, politics and elections are messy affairs that often bring about change. We will face some challenges as we work to adapt to a new Congress. But just like we always have, we will be prepared and ready to meet those challenges. We have faced, weathered and succeeded in Congress following tumultuous elections like the 2016 election that brought us the Trump administration and a Congress completely controlled by Republicans.

Just two years after that, the Democrats seized back control of the House, and just two years later, President Biden was elected, and the Democrats took complete control of both chambers of Congress.


We have been down this road before, and we have succeeded in every Congress. Our issues do not rise and fall based on partisan control because our issues are the safety of the public and the safety and well-being of the men and women in law enforcement. Administrations and congresses may change, but our priorities and commitments to our members do not.


It may seem to us now that this is a major shift in our body politic, but as the old adage goes — the more things change, the more they remain the same. As I noted above, one of the outcomes of this election cycle is another 50–50 Senate. The only change is the party that controls the House. Given the FOP's major successes in this, the 117th Congress — which was extremely divided along political lines — we are confident that we can succeed in the Congress that will be sworn in this upcoming January.

However this situation is resolved, we expect the strident rhetoric of the campaign to give way to reason and reality.

Regardless of party, the members of the 118th Congress were elected to serve their constituents and get the people's business done. The FOP will have the same problems with both parties in this Congress as we did in the previous Congress. Republicans will be hostile to grant programs that benefit state and local law enforcement and legislation recognizing the collective bargaining rights of public safety officers. Democrats will continue to push for criminal justice "reforms" that will make it more difficult to keep our citizens and our officers safe. And, of course, we will need the help of both parties to repeal the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO).

The FOP is the most prominent voice for law enforcement, and I want to assure all of our members that our voice will be heard over the next two years, no matter which party controls the House or Senate. But over the course of this 118th Congress, the FOP will be fighting for you in the White House, in the Senate and in the House. We will ensure our top priorities are re-introduced in the next Congress, and we will continue to fiercely advocate for them. FOP







Pass the Protect and Serve Act

s this article is being written, the United States House of Representatives is poised to flip Republican, with the party only needing one more seat for a majority. No doubt the violent crime epidemic in this country, to the tune of the highest homicide rate since the 1990s and a historic number of police officers being shot, played a major role in the house flipping. According to polling data, violent crime was the number two issue for voters going into election day. Thanks to the tireless work of every FOP leader in this country, we were able to keep the violent crime issue front and center for voters.

Now that Republicans control the House, it is not enough to talk about how they care about violent crime and how much they support police officers. It is time for action. There have been 290 police officers shot in this country as of November 15 — ambush attacks are up, assaults are up, and it is not hyperbole to say we are being hunted in the streets simply because of the uniform we wear.

I am keenly aware of this because, unfortunately, my home state of Texas leads the nation in officers shot. Thus, when the 118th Congress convenes, the House must pass the Protect and Serve Act, which would make it a federal crime to knowingly assault a police officer. Of course, it would still have to pass the Senate to become the law of the land, but it would force every lawmaker to be on the record about where they stand on this issue.

This would send a powerful message to any dirtbag who thinks about assaulting a police officer. There will be serious federal prison (day for day) and consequences for their actions. This will take the power out of the local, rogue DAs and activist judges who consistently dismiss and reduce charges of criminals who assault police officers. This will restore the public's faith in the criminal justice system and the rule of law. Make no mistake, when a miscreant assaults a police officer, it is an attack on our very system of law and order, and the continued violence against law enforcement is truly a stain on our society. A stain that will never be forgotten and leaves heartbreak for officers and their families in its wake.

The Fraternal Order of Police will continue to advocate for our members, their safety, and justice for all victims. We will continue to sound the alarm about the crime epidemic in this country, and we will be relentless in our efforts to restore law and order in our country, never caving to the "woke" nonsense that is destroying our urban communities, and we will do it together.


been working diligently on expanding membership and creating new lodges. It was exciting hearing President Jim laying out his plan for the upcoming legislative session. Nebraska, keep up the fantastic efforts.

Per capita is now due. National per capita (dues) are due as of November 1 for the first half of 2023. Your National Membership staff has been busy processing membership dues, printing, packaging and mailing 2023 membership cards. We have a great staff, and during this time of year, every staff member in the office (those in other departments) has a hand in getting this massive project completed. As of this writing, we have processed over 1,000 lodges and printed over 200,000 cards. Local and state lodge secretaries, though it is permissible to submit your membership changes via hard copy to the National Membership office, it is suggested and preferred that you do so electronically. The hard copy process requires my staff to manually enter the changes, which slows down the process and subjects us to errors. I also suggest payments to the National Office via Automated Clearing House (ACH), which expedites the process, and you avoid credit card convenience fees. If you have not yet paid your local dues, please contact your local lodge secretary.

Most local lodges will have their elections this month. Even if there is no change in your lodge officers, the Membership Department needs your updated roster showing the new term expiration date. Failing to send in the update will result in your lodge officers being locked out of the membership (VUE) system. If locked out, you can't make changes to your membership information and other important administrative functions.

I am very pleased to inform you that after several years of reviewing a new automated membership data system, we have selected a vendor to develop the program. The contract is currently being reviewed by counsel, and once the terms are agreed to and signed off, we will begin work. This will be a very intense project that my staff and I will devote our full attention to bringing to fruition. Our target date for rollout, which is extremely aggressive, is the National Conference in August 2023. Stay tuned.

In closing, whether you celebrate Rohatsu, Hanukkah, Kwanzaa or Christmas, I wish you and your family a safe and happy holiday season. Know that your National Staff is here to help you in any way we can. Let us all join in unity to continue to make our Order stronger. I look forward to talking to you or seeing you at our next meeting. FOP

Recruitment and Retention Update

t the National Fraternal Order of Police Spring Board meeting held in Philadelphia, Pennsylvania, in April, an initial call to action was generated. Recruiting and retention have been a nagging consequence of the "defund the police" movement since the death of George Floyd in May 2020. Originally seen as strictly an employer and management dilemma, it was becoming distinctly clear that the largest organization representing rank-and-file law enforcement had a stake in the game. I made that plea to those in attendance in Philly, and help soon followed.

As police departments across the country were struggling with recruitment and retention, we were observing accelerated career burnout, which of course, resulted in a diminished workforce and overworked law enforcement professionals. Already dealing with a higher-than-normal profession-driven rate of suicide, it was clear that as exhaustion set in, additional stressors were being placed upon our law enforcement professionals.

By July 2022, a temporary FOP committee was established by President Pat Yoes and Vice President Joe Gamaldi to address the crisis in recruitment and retention. Chaired by myself, the following members were appointed: Willie Jinkins III (La.), David Cuevas (Texas) and Jeffery Benge (Ohio). The committee's first look at this crisis was to explore potential opportunities with Job Corps as they have 121 Job Corps centers across the country, along with six regional offices. After some initial discussions with Job Corps, Apprenticeship USA appeared as another viable partnership. The FOP has been in preliminary discussions with both organizations.

On September 29, President Yoes, Executive Director Jim Pasco and I met with U.S. Attorney General Merrick Garland, Deputy Attorney General Lisa Monaco and Associate Attorney General Vanita Gupta, along with other major law enforcement organizations at the offices of the Attorney General in Washington, D.C. At this meeting, we offered some suggested solutions surrounding the crisis and proposed to partner with other law enforcement organizations in such

a manner as was done when the groups agreed on a consensus policy on the use of force several years ago. Other law enforcement groups present were the International Association of Chiefs of Police, National Organization of Black Law Enforcement Executives, Major Cities Chiefs Association, Major County Sheriffs of America, National Sheriffs' Association, Police Executive Research

Forum and Federal Law Enforcement Officers Association, to name a few. Also present was Acting Director Rob Chapman from the COPS Office.

We left that meeting with some positive responses from the Department of Justice, yet the burden of making something happen still rests with us. Several exploratory discussions have taken place with representatives from the Department of Labor and the Boy Scouts of America. Each communication seems to peel back yet another layer of the onion as the FOP aggressively pursues every avenue in addressing the current crisis in recruitment and retention. Most recently, we endorsed a grant proposal submitted by Dr. Jeremy Wilson from the University of Michigan on a study he wishes to conduct on this crisis.

If your lodge is a part of any partnerships with the Boy Scouts of America's Explorer program or working with any other sort of apprenticeship program, I definitely want to hear from you. As a matter of fact, any ideas, or thoughts on how we can leverage programs or initiatives already in place would be helpful to our committee. Please reach out with your ideas.

What "Fraternal" Really Means

raternal. The very first word in the name of our organization defines us. This word has different meanings for different people. Various dictionaries and online resources define the word fraternal as "brotherly" or "of or like a brother or brothers." It describes the togetherness and bond we as brothers and sisters have in the law enforcement profession and in the FOP as we stand together through good times and bad. Recently, I had the privilege of witnessing a tribute that yet again reminded me of the importance of fraternalism and what it should mean to all of us.

As you all have learned by now, this past summer, we lost a great brother and leader in former National FOP President Gil Gallegos. His accomplishments were many, including starting the NFOP Diversity Committee, his work and advancement in the labor realm and his legislative efforts in Washington, D.C. President Gallegos also had a long, distinguished career at the Albuquerque, New Mexico, Police Department, where he rose to the rank of chief. At his funeral services, numerous people who had served under him at APD and within the FOP described him as a "cop's cop" and one who never forgot where he came from or what it was like on the street for line officers.

But there is another great story behind that story.

If you knew President Gallegos over those years or you saw him anywhere, you also saw another brother right by his side, Brother James Flores. Brother Flores currently sits as the National trustee for New Mexico and has served various roles in the FOP for many years.

Brother Flores led all of the election campaigns for President Gallegos on the National level and was his closest friend over all those years. It was a rare occasion you would see one without the other at

an event. This friendship continued long after President Gallegos served on the Executive Board and continued until the day he left us for his seat at the heavenly Executive Board table.

Although his health declined in recent years, Brother Gallegos never lost his love for the FOP or being with his brothers and sisters. Even when it was probably not in his best health interests, he would come to meetings and spend time with his brothers and sisters as his energy allowed. Anywhere he went, there was Brother Flores helping him get to and from the events, helping him get around to see people and simply just caring for him. Like a brother would do.

Brother Flores never wavered in his love and care for Gil, and it showed to anyone watching. Until his very last day on earth, Brother Flores was by his side, doing whatever he could to make him comfortable as often as possible. At the services, family members even spoke about how they chose to move Gil's residence during his final days closer to Brother Flores because seeing him meant that much to Gil. While sharing memories about President Gallegos, friends and loved ones told many stories about Brother Flores and all he did for his friend. No matter how hard or inconvenient, he was there for Gil until the end. his month's National FOP
Member Spotlight hails from
the Bluegrass State, Kentucky.
He has the unique distinction of
serving as the elected sheriff of Clark
County (population of 37,000)
and as the Kentucky State Lodge
president (9,879 members/68 lodges).
He is one of the most active State
Lodge leaders in the FOP. He is well
respected by members from around
the country and by political leaders
at the local, state and federal levels,
especially by U.S. Senate minority
leader Mitch McConnell.

Under Kentucky State President Berl Perdue's leadership, the Kentucky State Lodge has grown in membership, political capital and lodge financial stability. He is always looking for ways to improve and is innovative in his approach in serving his membership. He is a trailblazer in encouraging his local lodges to engage in their respective communities by sponsoring various programs and events centered around children. He also exudes true fraternalism to every sister and brother he meets.

We asked President Perdue to share his story with us. We want to know about his past accomplishments, what he is working on now and his thoughts on what we need to do in the future. We are as proud of him as the members of the Commonwealth of Kentucky are. Here is his story.

I am the sheriff of the Clark County, Kentucky, Sheriff's Office. I've been sheriff of our office for the past 16 years, serving four terms. I recently won re-election for a fifth term, unopposed. Prior to being elected sheriff, I worked at and retired from the Winchester Police Department (WPD) after 25 years



of service. I retired from WPD with the rank of detective sergeant. I am approaching 41 years of continuous service in my county.

I joined the FOP on my first day on the job — May 16, 1982. I had an uncle who was a police officer and a board member of the Lexington, Kentucky, lodge. He was all FOP! That is where my initial interest very first started. So, here we are, nearly 41 years later, and I'm still FOP through and through.

I initially started out in FOP leadership at my local lodge as the secretary. I eventually ran for and was elected local lodge president, serving 20 years (1991–2011). I ran for and was elected vice president of the Kentucky State Lodge in 1999 and served as VP from 1999–2011. In 2011, I was elevated to president midway through that year when the current president, Spike Jones, resigned to take a position as chief. Currently, I'm serving 11 ½ years as the Kentucky State FOP president.

My role as president is that of an organizer, mentor to younger members and mediator. My greatest satisfaction is helping local lodges and members come to agreements and solve any problems they have. I am especially proud to mentor



young members and prepare them to become leaders of our great organization. This involvement gives me great satisfaction.

Our future is bright in Kentucky. We've had really good legislative success over the past three years. We've re-established and made new positive relationships with our legislators. This has been a tremendous asset to our membership. This is something we will continue to work on and expand. We have started a new funding source for our State Lodge that shows great promise. We are excited about that aspect and feel like we will be on very stable ground sooner rather than later. Our membership continues to grow, and we will also concentrate on the expansion of new lodges.

I think our proudest accomplishment is the fact that



candidates seeking office from the local level all the way to the state and federal level seek us out now for our FOP endorsement. Even judges, all the way to the Kentucky Supreme Court, seek out the FOP for endorsements. This shows how far we have come and shows our organization's influence in government. This is a source of pride for us, as it wasn't always this way. We, the Kentucky State FOP, are now players, not pawns, in the political world.

I know that the FOP is important to all law enforcement, members or not. We are the largest police organization in the world. The important thing is that we fight each and every day for better benefits and working conditions for our officers. And just as importantly, we fight for the rights and due process of our officers. Many times, we are their



only voice. That's my favorite thing concerning the FOP — the fact that we support our members each and every single day. Nothing gives me more satisfaction than to see our members win in court or even win as far down in the councils of cities.

I really don't think I have a great secret for success. I simply feel that if you are a hard, dedicated worker who is fair and honest with your members and employees, you can and will be successful. However, you must be forward thinking and look down the long road. Try to foresee problems before they happen and have a plan to correct the problem. I stay motivated unintentionally. I'm always thinking and thinking. I challenge myself by asking, "What can I do better, what can I improve on and what new idea or concept can I implement?" This is what motivates me - the success of our organization.

I would advise our members, young and older, that it's never too early and certainly never too late to get involved with your local lodges. Volunteer for every lodge event, attend all your local lodge meetings and don't be afraid to make suggestions. You have a voice, so be heard. Step up and be a leader. You don't have to hold an office to be a leader. Being a member who can be counted on for lodge business and events is a grassroots leader.

In closing, I leave you with one thing. I've repeated this for 40 years, and it still rings true today. "If it's not good for the Order ... then it's not good!" FOP





Law Enforcement Jobs You Can Obtain With a Master's Degree in Criminal Justice

Jobs that require a master's degree in criminal justice are found throughout law enforcement. Here are some examples.

- Private investigator. A private investigator is usually hired by individuals or they work for firms to find more information for their clients. They find facts and analyze information to find missing persons, investigate crimes and explore peoples' backgrounds.
- Forensic psychologist. Forensic psychologists typically work with convicted inmates to assess their mental health status. They also conduct investigations and research studies, and design treatment programs, as well as provide expert witness testimony in court, among other responsibilities.
- Criminologist. Simply put, criminologists study crime.
 They study the causes of crime and make recommendations to support public policy and law enforcement. They often conduct interviews, analyze data and use statistics and other means of exploration.
- Police and detective supervisor.

- Police and detective supervisors oversee officers and detectives under them. They schedule, arrange and provide training, as well as conduct reports and participate in investigations.
- DEA agent. DEA agents enforce drug laws, investigate drug-related crimes and work to prevent the distribution of illegal drugs.
- Attorney general investigator.
 An attorney general investigator investigates criminal activity and collects evidence for attorneys to use to prosecute suspected criminals. They also conduct interviews, coordinate investigations, carry out research and compile important documents and reports to use in court.
- Cybercrime investigator. A
 cybercrime investigator works
 to identify individuals who use
 online databases and websites
 to commit crimes. These
 investigators may explore the hard
 drives of confiscated computers to
 recover data and files.



Republicans Win Narrow House Majority; Dems Hold on to the Senate



t this writing, the final votes in just a few races are still being tabulated, but what we know right now is that Republicans will take control of the House, but with a very narrow majority.

Representative Kevin O. McCarthy (R-Calif.) defeated Representative Andrew S. Biggs (R-Ariz.) on a 188–31 vote within the Republican Conference for the nomination to be the next speaker of the House. Once the 118th Congress is convened in January, the House will elect its speaker.

Representative Stephen J. Scalise (R-La.) was the unanimous choice of the conference to take over as the majority leader, as was Representative Elise Stefanik (R-N.Y.) for conference chairman.

Representative Nancy P. Pelosi (D-Calif.) announced that she would not seek to be re-elected as minority leader but would continue to serve as a member of the House. Representative Steny H. Hoyer (D-Md.) also announced he would not seek a leadership post and endorsed Representative Hakeem S. Jeffries (D-N.Y.) to be the next minority leader. The FOP will be monitoring developments when the Democratic caucus holds their leadership elections in December, but it is widely believed that Representative Jeffries will lead the Democrats in the House in the next Congress.

In the Senate, Democrats flipped one seat in Pennsylvania with the election of John K. Fetterman to succeed the retiring Patrick J. Toomey (R-Pa.). At this time, there is no certified winner in Alaska (where both remaining candidates are Republican) or Georgia. The Democrats have 50 seats in the Senate right now, meaning they will retain control of the Senate because Vice

The Democrats have 50 seats in the Senate right now, meaning they will retain control of the Senate because Vice President Kamala D. Harris can break any tie.

President Kamala D. Harris can break any tie. The Georgia election will be decided on December 6 when Senator Raphael G. Warnock (D-Ga.) will face Republican candidate Herschel J. Walker. If Senator Warnock is re-elected, the Democrats will have a one-seat majority. If Walker prevails, we will have another 50–50 split in the Senate.

Senator Charles E. Schumer (D-N.Y.) is all but certain to be re-elected as majority leader when the Democrats have their leadership elections in December. Senator Mitch McConnell (R-Ken.) was re-elected as minority leader over Senator Richard L. Scott (R-Fla.), who also ran for the position, on a 37–10 vote with one abstention.

Return From Recess — Congress Reconvenes

Following the midterm elections, Congress returned to session. After a week-long break for Thanksgiving, both chambers returned to order to tackle several "must-pass" bills before the end of the Congress.

The federal government is currently funded through a continuing resolution, which expires on December 16.

Congress will need to pass an omnibus appropriations package or adopt another continuing resolution to fund the

government into the new year after the swearing in of the 118th Congress.

Congress will also be considering H.R. 7900, the National Defense Reauthorization Act, for fiscal year 2023. This legislation passed the House and is pending in the Senate. Talks between the congressional leaders have been ongoing for several weeks now, but there is no final version available at this writing. We have been advised by staff on the Senate Committee on Armed Services, however, that a modified version of H.R. 8142, the Department of Defense Law Enforcement Credential Act, will be part of the final draft. The provision would require each military department in the U.S. Department of Defense (DOD) to develop a standardized law enforcement identification credential for civilian DOD law enforcement officers and issue such credentials at no cost to the officers. Right now, too many civilian law enforcement officers do not have a law enforcement credential and are forced to rely solely on just the standard DOD-issued common access card. This legislation will ensure these officers are clearly identified as DOD law enforcement officers.

Senate Passes Fair RETIRE Act!

Just before the Thanksgiving recess, the Senate considered and

passed H.R. 521, the Fair Return for Employees on Their Initial Retirement Earned (RETIRE) Act, by unanimous consent. The legislation, which the FOP strongly supported, will allow federal law enforcement officers who were severely injured in the line of duty and, as a result, unable to continue their service as a law enforcement officer, to maintain their 6(c) early retirement benefit provided they take a civil service position in the federal government after their injury. The measure is now on its way to the president, who is expected to sign it into law.

First PSOB Claim Under New Law Approved

The family of U.S. Capitol Police Officer Howard C. Liebengood, who took his own life a few days after being on site during the attack on January 6—the day an angry mob broke into the U.S. Capitol and the world witnessed the rioters violently assault law enforcement officers—shared with the National FOP their news that their death benefits claim was approved by the Public Safety Officers' Benefit

(PSOB) program. This is the first claim awarded under the new law, the Public Safety Officer Support Act. The FOP was instrumental in the development and passage of this legislation, which was signed into law in August.

While no amount of money will bring Howie back to his family, their successful claim is an important step in acknowledging that law enforcement suicides are service-connected and should be seen for what they are — lineof-duty deaths.

The Liebengood family issued the following statement:

"We were recently notified that the Department of Justice officially determined our beloved family member, U.S. Capitol Police Officer (USCP) Howie Liebengood's passing was in the line of duty under the PSOB program. The determination is significant, healing and relieving, and we are grateful for it.

"We hope the changes to the PSOB program, which allowed Howie to receive this designation, will serve as a model for other entities that offer similar benefits and recognition. This is an important step in a longer effort to change outdated processes and attitudes. We also hope that this helps other families who have felt the pain of losing a loved one to suicide.

"Anyone who knew Howie knew he was kind hearted and fiercely loyal. We all desperately miss his one-ofa-kind smile and his warm, gentle temperament, but we take some solace in knowing that Howie officially has received this well-deserved honor.

"We appreciate the opportunities we've had to meet with the Department of Justice and others before this decision. We are grateful for the assistance of many stakeholders, including the Fraternal Order of Police and Blue H.E.L.P., which have stood alongside us and advocated on behalf of families like ours. We also applaud the leadership of Congressman Trone, Congressman Reschenthaler, Senator Duckworth, Senator Cornyn, Howie's Senator Kaine and other members of Congress on this issue.

We look forward to continuing to reduce the stigma around mental health

and suicide for public safety officers who make sacrifices for us all."

The mental and spiritual injuries sustained by America's brave law enforcement officers in the field are real and can be just as disabling or deadly as any physical injury. A death like Howie's is just as service-connected as any other line-of-duty death, and we believe the PSOB's decision to award benefits to the family is the right one. Their family will always be part of our family.

Congress May Still Act on FOP-Backed Bills Before Adjournment

Earlier this summer, the Senate passed five bills supported by the FOP by unanimous consent. During the current recess, the GMAC staff have been working to get these non-controversial but important bills to the House floor under a suspension of the rules.

- S. 1046, the Residential Substance
 Use Disorder Treatment Act,
 which would expand access to
 important substance use treatments
 in jails and prisons around the
 country and help those exiting
 correctional facilities continue their
 treatment in the community
- S. 2151, the Strong Communities
 Act, would build on the communitypolicing model by establishing a grant
 program for local law enforcement
 agencies to assist in recruiting officers
 from their own community
- S. 3860, the Invest to Protect Act, would establish a grant program administered by the Community Oriented Policing Services (COPS) Office, which would be used for the training of officers from police departments that employ less than 200 law enforcement officers
- S. 4003, the Law Enforcement
 De-Escalation Training Act, would
 provide \$70 million in annual grant
 funding from the Edward Byrne
 Memorial Justice Assistance Grant
 (Byrne-JAG) to state and local law
 enforcement agencies to train officers
 in de-escalation tactics and alternatives
 to the use of force
- S. 4007, the Fighting Post-Traumatic Stress Disorder Act, directs the

U.S. Department of Justice to develop a treatment program for public safety officers experiencing acute stress disorder or posttraumatic stress disorder (PTSD)

We believe we have made progress on S. 4003, and of all the bills listed above, this seems to be the most likely to be voted on in the House.

We also have three other bills awaiting action in the Senate. The GMAC staff is engaged with Senate leadership and the leadership of the committees with jurisdiction in an effort to get these pieces of legislation to the Senate floor under a unanimous consent agreement.

- H.R. 263, the Big Cats Public Safety Act, which would strengthen existing restrictions on the possession and exhibition of big cats, including restricting direct contact between the public and these animals
- H.R. 1260, the Bipartisan Solution to Cyclical Violence Act, which would allow HHS to select existing violence prevention or intervention programs administered by state and local trauma centers to receive federal grants to expand existing programs, study the effectiveness of those programs and examine their impacts on reincarceration and re-admittance rates
- H.R. 6538, the Active Shooter
 Alert Act, which would establish
 a national coordinator within
 the U.S. Department of
 Justice (DOJ) to establish and
 administer an Active Shooter Alert
 Communications Network.

FOP Calls on Congress to Make DEA Scheduling Authority Permanent

The Fraternal Order of Police sent a letter to congressional leaders in both the House and the Senate urging Congress to pass legislation that would make permanent the temporary authority of the Drug Enforcement Administration (DEA) to execute class-wide scheduling of illicit fentanyl-related substances or analogs, as schedule I substances under the Controlled Substances Act (CSA).

Clandestine chemists create new synthetic variations of fentanyl by introducing minor structural modifications, resulting in new, noncontrolled fentanyl analogs specifically engineered to skirt U.S. law. In 2018, the DEA used its authority under Section 201 of the CSA to place all non-scheduled fentanyl-like substances into Schedule I temporarily, on an emergency basis, for two years to combat this process based on their chemical structure and because they are purely illicit drugs with a high potential for abuse and no reasonable medical purpose. This means that anyone who possesses, imports, distributes or manufactures any illicit fentanyl analog is in violation of the CSA, which makes it easier for law enforcement to investigate and prosecute traffickers and criminal organizations.

These analogs are killing Americans. Data from the Centers for Disease Control and Prevention (CDC) has determined that approximately 100,000 Americans have died as a result of an overdose between April 2021 and February 2022. The vast majority of these deaths, more than 75,000, have come from opioids such as fentanyl and fentanyl-related substances. The CDC is also raising the alarm about fentanyl and fentanyl analogs being mixed with other illicit substances like cocaine and heroin.

Congress has repeatedly and overwhelmingly voted to extend this temporary authority, but this is not a temporary problem. The FOP told Congress to get serious about attacking our nation's fentanyl problem and reduce the number of Americans who perish from taking these drugs, and make the DEA's authority permanent to ensure that illicit fentanyl and any analogs remain on schedule I. Without granting the DEA the authority to permanently classify fentanyl analogs as they become available, our communities and American lives are in jeopardy.

In fact, a study done earlier this year by the National Bureau of Economic Research found that union employees are four times more satisfied with their jobs and working conditions than those of their non-union counterparts. To those law enforcement officers who have brothers and sisters in the field across the nation, it is probably fitting to assume that you can see why there exists such a discrepancy in job satisfaction.

According to the Bureau of Labor and Statistics, over 14.3 million employees belong to unions across the country. In fact, 2020 alone saw a membership rate increase of 10.8%. Moreover, public-sector membership rates are over five times higher than those of private-sector membership rates. Though

The Jack Dudek Award

ince 1985, there have been 34 members of the Fraternal Order of Police who have been recognized as the National Fraternal Order of Police Member of the Year. This is the most prestigious award presented by the National Lodge and is formally known as the Jack Dudek Award.

Who was Jack Dudek, and what makes him worthy of such a prestigious award being named in his honor?

Jack Dudek served as the president of the National FOP from 1946-1965 and was the first National FOP president who was born in the 20th century. Dudek was just 15 years old when the Fraternal Order of Police was formed and was 25 years old when he joined the Cleveland Police Department to begin his 38-year career.

Dudek was a well liked and "affable" officer who was promoted to detective in 1927. One of his many strengths was his ability to communicate and his command of the spoken word. So much, in fact, that he was selected to give a 90-second broadcast over the Universal Radio Network at Chicago's World Fair in 1933.

Dudek was a charter member of Lodge #8 when it was formed in 1934. He served the lodge in various capacities, including secretary-treasurer, and chaired the Ways and Means Committee for six years. From 1941 to 1946, Dudek served the Ohio State Lodge as chairman of the Legislative Committee. He began 36 years as an officer in the National Lodge in 1941 when he was elected as the Ohio trustee in Toledo.

Dudek enlisted in the U.S. Navy shortly after America entered World War II. He only served a few months before he suffered serious arm injuries, which necessitated several surgeries and a discharge from the service. Dudek returned to his duties as a Cleveland police officer and rose to the rank of lieutenant before retiring in 1964.

Today, our number one legislative priority on the National level is the Social Security Fairness Act, but issues with social security have long been a thorn in the side of National leadership. Back in 1939 and well into the 1960s, there was a move to force police officers into social security and away from public pensions. In 1957, a bill was introduced in the House that removed the exclusion of police and firefighters entirely but was defeated 162-64.

Dudek served our great Order with distinction during some of the most turbulent times in history, including the Korean War, the Vietnam War and the civil rights movement. Dudek had many accomplishments during his distinguished career, and not all of his ideas were met with favor from lodges, which felt there would be a financial burden to their members associated. Dudek's proposal to create an annual FOP wage and benefit survey was one such idea.

Instead of becoming a burden, the survey was soon the best known and most widely used service of the National Lodge. For a comprehensive look at the career of Brother Dudek and his many accomplishments, I highly recommend you read:

The Fraternal Order of Police, 1915-1976: A History by Justin E. Walsh, Ph.D.

"I was once asked by an elderly gentleman, 'Jack, what is the formula for your success?' I replied that I had no formula for my success, only a formula for my failures. 'What's that?' he said. Trying to please everybody," I said.

In the past few years, Colorado has been able to secure legislation for a peace officers mental health grant program, which includes language to allow the FOP to apply for these monies to fund their FOP state-run programs.

in strategic crisis communications and advocacy. Next, John V. Berry will present on a hot topic in the law enforcement world: the decriminalization of marijuana and what it means for police officers. Can police officers in states where marijuana is legalized or decriminalized be disciplined for using marijuana? Mr. Berry, who previously served as the general counsel to the United States Park Police and the United States Capitol Police Federal labor unions, will provide an overview of how states are handling this question. This presentation will also explore how legalizing or decriminalizing marijuana may impact internal affairs such as department policies. Mr. Berry will use recent cases to show the risks associated with using marijuana, even where it is legal.

Lance J. LoRusso, a former law

enforcement officer, has been a useof-force instructor for almost 30 years. In recent years, use of force and the reasonableness of police officers' conduct has been a consistent headline in the news. Mr. LoRusso, who has represented over 100 officers in officerinvolved shootings and in-custody deaths, will use his expertise to discuss defending officers who are dealing with use-of-force issues in administrative, civil and criminal matters. This presentation will also focus on how to handle the media attention that these types of cases attract. Mr. LoRusso is a regular presenter at the Legal Counselor Seminar, and his presentations consistently provide invaluable insight and information.

Another critical subject in the law enforcement community is the use of social media. Social media platforms such as Facebook, Twitter and Instagram are increasingly utilized as a tool for law enforcement purposes such as discovering and investigating criminal activity, informing the communities about volatile situations and identifying names and locations of dangerous individuals or activities. These platforms allow officers to interact with citizens and share their

viewpoints on topics - good or bad. National FOP Associate General Counsel Marissa R. Borschke will discuss how police departments across the country have opted to enact policies to ensure that social media sites are being used to assist law enforcement and not hinder it. Ms. Borschke's presentation will analyze various policies implemented in departments across the country as well as how courts are handling challenges to these policies. Specifically, Ms. Borschke will address the need for police departments to create a social media policy that balances an officer's First Amendment right of free speech and the department's interest in promoting operational efficiency.

Qualified immunity continues to be at the forefront of legislative, media and judicial attacks on law enforcement officers. As a follow up to prior years' presentations, National FOP Associate General Counsel Christopher R. Green is back to provide an update on the qualified immunity doctrine's continued viability. While state governments seek to limit the doctrine's effectiveness, courts across the country are consistent in its application. This doctrine provides complete immunity for government officials, including police officers, from suit as long as their actions do not violate clearly established statutory or constitutional rights. Last year, Mr. Green provided a thorough explanation of the standard to establish this defense. This year's discussion will focus on how several state governments have undertaken their own form of qualified immunity reform legislation and the potential impact. He will discuss the current status of the defense according to the Supreme Court, anticipated changes due to the addition of a new justice and key developments in cases from every circuit.

Mike Coviello, associate general counsel for the Labor Services Division of the National FOP, returns to cover the right to fair representation. Mr. Coviello has extensive experience in all union-related matters and has represented FOP members since 1998. Indeed, unions have the duty to represent all employees — whether members or not — in good faith and

without discrimination for practically every action that a union may take. Mr. Coviello will address the common issues that arise under this duty, including strategies to deal with conflicts of interest. Mr. Coviello will also provide a post-lanus update. States have had different reactions to the decision in Janus v. AFCSME, Council 31, 138 S.Ct. 2448 (2018), where the Supreme Court determined that it was unconstitutional for public sector labor unions to collect representation fees from non-union members. This presentation will provide an overview of any major decisions and legislation that were enacted in the aftermath of Janus.

Lastly, General Counsel Larry H. James will present on ethical considerations for attorneys representing law enforcement. Specifically, Mr. James will provide strategic advice on how to handle ethical issues such as conflict of interests in representing multiple officers involved in the same shooting. Additionally, Mr. James will discuss representing the union and its members and how this creates other ethical issues where the Model Rules of Professional Conduct and case law offer little guidance. Mr. James will use case-specific examples to demonstrate the application of the Model Rules of

Professional Conduct in a variety of police-related scenarios.

The National FOP looks forward to seeing you in Las Vegas in February and to holding informative, timely discussions on issues impacting law enforcement. In addition to the presentations, the materials submitted and provided to all attendees will be substantial and all-encompassing. New Retired Law Enforcement Concealed Carry Legal Defense Coverage



he FOP Legal Defense Plan's
Board of Trustees has had
numerous requests from current
and prospective participants to review
broadening coverage under the current
HR-218 LEOSA Plan. After diligent
review and analysis, the Board voted to
make the following changes.

The HR-218 Plan coverage was replaced with the FOP Retired Law Enforcement Concealed Carry Legal Defense Coverage (CCC). The expanded coverage will offer unlimited legal defense for civil and criminal claims associated with the legal carrying and/or use of a concealed weapon: All reasonable and necessary legal defense costs are now covered in full when using a plan attorney. This new expanded plan will provide coverage for not only those retirees who were qualified under

LEOSA, but also those retirees who are qualified under their own state laws to carry a concealed weapon. Coverage does not include claims related specifically to the open carrying of firearms.

The CCC went into effect on January 1, 2021. If you are a current HR-218 retired member, unlimited coverage and the enhanced benefits automatically took effect on January 1, 2021, with no additional cost. Upon renewal of your coverage in 2021, the new annual fee of \$75 will take effect. For all new retired members joining the plan after January 1, 2021, the annual fee is \$75.

If you are an active law enforcement officer covered by the FOP Legal Defense Plan, LEOSA coverage is already included. CCC is for **retired law** **enforcement officers only** and separate from the FOP Legal Defense Plan.

The Board is excited to provide yet another excellent benefit for our FOP law enforcement brothers and sisters. In today's unstable times, it is crucial to make sure you are protected.
